6. **Bidder submitted their bid electronically to the office Ichchhakamana Rural Municipality Office , Kurintar, Chitwan through PPMO web site : [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) or below 12:00 hours on 2077/02/16BS (2020/05/29D), Bids received after this deadline Shall be rejected .**
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00hrs, 2077/02/16BS (2020/05/29AD)** at the office of *Ichchhakamana Rural Municipality Office, Kurintar , Chitwan* Bids must be valid for a period of **120 Days** after bid opening and must be accompanied by a bid security amounting to **a minimum 2.5% to 3% of Estimated Amount**, which shall be valid for **30 days** beyond the validity period of the bid .
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. Other mandatory information as per PPA 2063 and PPR 2064. The Employer reserves the right to accept or reject , wholly or partly any or all the bids without assigning reason , whatsoever. Bidders are encouraged to visit the site and assess the actual site condition before submitting their bid.
