Bidding is open to all eligible Nepalese and Foreign Bidders.
2. *Office of Ichchhakamana Rural Municipality* invites sealed bids from eligible bidders for *Different construction work and identification numbers as per data given below in list* under National Competitive Bidding procedures. Only eligible bidders with the following key eligibility criteria should participate in this bidding.

5. Pre-bid meeting shall be held at *Office of Ichchhakamana Rural Municipality, Kurintar, Chitwan* at *16th day on 1:00 hr for tender*.
6. Sealed bids must be submitted to the Execucative Office of *Ichchhakamana Rural Municipality, Kurintar, Chitwan* by hand/courier on *2077 baisak 14* before *12:00* for sealed tenders. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend *2077 baisak 14 at 14:00 hr* on 31st day at the Execucative Office of *Ichchhakamana Rural Municipality, Kurintar, Chitwan*. Bids must be valid for a period of *120 days* after bid opening and must be accompanied by a bid security amounting to a minimum of *Bid Security Amount per bid given below in list* which shall be valid for 30 days beyond the validity period of the bid. If the bidder wishes to submit the bid security in the form of cash, the bidder has to deposit cash in deposit account no: *c40101000021* of *Ichchhakamana Rural Municipality, Chitwan* in *Global IME Bank Ltd., kurintar, chitwan* and shall submit bank deposit voucher along with the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid submission shall remain the same as specified for the original last date of bid submission.
9. The Employer *Ichchhakamana Rural Municipality* shall have all the right for acceptance and rejection of the contractor in the bidding process.
